Thank you for your interest in the work of MVRDV; here are the rules for the free use of the material in the Press Room:

1. The name of the photographer needs to be mentioned at all times when published, readable near the picture used. The names of photographers appear in the text file sent with every download, along with the related image file name and its caption.
2. The project name and the name of MVRDV is to be mentioned with every publication, readable in the vicinity of the picture.

Copyright for the images is not transferred to the publication and remains at all times in the hands of the photographers or MVRDV as applicable.

Images **can** be used **free of charge** for:

- Publications about MVRDV and the buildings depicted
- Academic publications

Under the condition that MVRDV receives a copy of or a link to the publication (digital copy to pr@mrvdv.com or a hard copy to MVRDV, Public Relations, Achterklooster 7

NL - 3011 RA Rotterdam, Netherlands).
